In exercise of the powers conferred under Article 229(1) of the Constitution of India, the Hon'ble The Chief Justice is pleased to pass the following order:-

Sri B.V.L.N. Chakravarthy, II Additional District Judge-cum-Metropolitan Sessions Judge, Vijayawada is transferred and appointed as Officer on Special Duty against the vacant post of Registrar in the High Court of Andhra Pradesh, Amaravati, until further orders. The Officer shall report before the Registrar General, High Court of Andhra Pradesh on or before 13.07.2020.

The Officer is entitled to draw his pay and allowances attached to the post of Registrar in the High Court of Andhra Pradesh.

Sri B.V.L.N. Chakravarthy, II Additional District Judge-cum-Metropolitan Sessions Judge, Vijayawada shall hand over the charge of his post to the IV Additional District and Sessions Judge-cum-Judge, Family Court, Vijayawada and the IV Additional District and Sessions Judge-cum-Judge, Family Court, Vijayawada will be in full additional charge of the post of II Additional District Judge-cum-Metropolitan Sessions Judge, Vijayawada, until further orders.
