Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ order or direction more in the nature of Writ of Mandamus declaring the highhanded actions of the Respondents No. 3 to 5 trying to demolish and dispossess petitioners from their residential house, cattle sheds, manure pits, bore wells, pipe lines, Electrical lines and Transformer, purified drinking water unit etc., situated in Sy.No.99/2, in an extent of Ac. 1.42 cents of Mamuduru Village, Chejarla Mandal, SPSR Nellore District, without notice, and the highhanded action of Respondent No. 7 detaining the 2nd petitioner illegally on 04-06-2020 at about 9.00 PM for no reason, without registering any complaint, under the influence of 8th and 9th respondents, with a view to distribute house site pattas in the said land under PEDALANDARIKI ILLU SCHEME as the said land is classified as Grama Kantam in revenue records, as being Illegal, colourable excise of power, arbitrary and violation articles 14, 19, 21 and 300-A of Constitution of India, contrary to BSO and the law laid down in Nagarala Nirvasithula Welfare Association vs. The Government of A.P., followed in WP.No.1675 of 2020, dated 30-01-2020 and consequently direct the respondents not to demolish and dispossess petitioners from their residential house, cattle sheds, manure pits, bore wells, pipe lines, Electrical lines and Transformer, purified drinking water unit etc., situated in Sy.No.99/2, in an extent of Ac. 1.42 cents of

Mamuduru Village, Chejarla Mandal, SPSR Nellore District, without notice, and direct the Respondent No. 7 release the 2<sup>nd</sup> petitioner forthwith.

#### ORDER:

- The Writ Petition is dismissed as withdrawn as against 3. respondent Nos.10 to 12.
- Learned Government Pleader, on instructions, submits 4. that if the property in possession of the petitioners is required for any public purpose, the authorities will issue notice and follow the due process of law. The same is recorded. It is further observed that till the said exercise is completed, Status Quo as on today with regard to the subject property shall be maintained. In the manner indicated supra, the Writ Petition is disposed of. No costs.
