



## **HIGH COURT OF ANDHRA PRADESH AT AMARAVATI**

**Ref: Notification No.13/2023/Estt., dated 21.10.2022**

The High Court of Andhra Pradesh issued Notification No.13/2022 dated 21.10.2022 inviting applications from the candidates and conducted computer based objective type examination on 20-01-2023 for filling-up 135 posts of Office Subordinates.

The list of 133 candidates provisionally selected to the post of Office Subordinates is placed on the official website of the High Court on 23-02-2023 and the remaining two posts under process for sports category.

Out of 133 posts, the High Court issued appointment proceedings to 90 candidates to the post of Office Subordinate and 70 candidates are reported for duty.

Thus, the list of 63 candidates, who are provisionally selected to the next meritorious candidates from the merit list for recruitment to the post of Office Subordinate is placed on the official website of the High Court on 18-07-2023, directing them to appear for verification of Original Certificates from 24-07-2023 to 26-07-2023 in the High Court of Andhra Pradesh.

Out of 63 candidates 16 candidates are appeared for verification of original certificates.

The following 16 candidates who appear and produced valid original certificates are temporarily appointed to the post of Office Subordinate in High Court of Andhra Pradesh.
