  - b. Machine auto-lock
  - c. Power disruption
  - d. Browser Cache
  - e. Forced session time-out
3. Get your keyboard replaced in case of any issue before the start of Actual Typing Test. Getting the Keyboard changed during Actual Typing will lead to interruption which may lead to loss of exam time.
4. Back space key will not work in the exam.
5. After mock test, there will be five (5) minutes break. After that, the instructions will be displayed on the screen for five (5) minutes.
